PROMOTION DESCRIPTION: The Michael Carbonaro Sweepstakes (the “**Sweepstakes**”) begins on October 9, 2017 at 12:01 a.m. Eastern Time (“**ET**”) and ends on November 5, 2017 at 11:59 p.m. ET (the “**Promotion Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Spectrum Reach, 9100 S. Hills Blvd., Ste. 250, Broadview Heights, OH 44147 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal U.S. residents who are twenty-one (21) years of age or older and reside in the Spectrum – Cleveland service area are eligible to enter.
