

**The Hard Rock Rocksino's Wayne Brady Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE NECESSARY**

**PROMOTION DESCRIPTION:** The Hard Rock Rocksino's Wayne Brady Sweepstakes (the "Sweepstakes") begins on April 28, 2017 at 12:01 a.m. Eastern Time ("ET") and ends on May 19, 2017 at 11:59 p.m. ET (the "Promotion Period"). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Spectrum Reach, 9100 South Hills Blvd, Suite 250, Broadview Heights, Ohio 44147 ("Sponsor"), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal U.S. residents who are twenty-one (21) years of age and reside in the Spectrum – Cleveland service area are eligible to enter. Employees, officers and directors of Sponsor, Charter Communications Operating, LLC, Northfield Park Associates, LLC d.b.a. Hard Rock Rocksino Northfield Park, and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the "Promotion Entities") and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. **HOW TO ENTER:**

To enter the Sweepstakes, visit the website [www.clevelandticketsweepstakes.com](http://www.clevelandticketsweepstakes.com) (the "Website"), complete the entry form with the information requested, and follow the on-screen instructions to submit your entry and receive one (1) entry into the Sweepstakes. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

All entries must be received by the end of the Promotion Period in order to participate. The Website's database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. **WINNER SELECTION AND NOTIFICATION:** At the end of the Promotion Period, one (1) potential prize winner will be randomly selected from all eligible entries received during the Promotion Period. The potential prize winner will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected.
